1. Acceptance of Terms

The CFTR2 team members ("CFTR2"), the Cystic Fibrosis Foundation ("CFF"), and Johns Hopkins Hospital ("Johns Hopkins") provide access to this web site (the "Site") subject to the acceptance of this User Agreement ("Agreement") by any person accessing, browsing, or otherwise using the CFTR2 website ("User" or "you").
